LIABILITY RELEASE (Release of All Claims)

This includes, but is not limited to, any activity on the property of **Faith Lutheran Church of Knoxville, Inc.** and all off site activities connected **with Faith Lutheran Church of Knoxville, Inc.** Furthermore, we (I) hereby assume all risk of personal injury, sickness, death, damage and expense as a result of participation in any activity recreation and work activities involved therein. We (I) understand that there are risks of injury associated with the activities my child-participant is going to be engaged in, and we (I), with knowledge of those risks, agree that no claim, suit or demand of any kind will be made against **Faith Lutheran Church of Knoxville, Inc.** This includes, but is not limited to, those claims, suits, or demands arising out of the negligence of **Faith Lutheran Church of Knoxville, Inc.** and its agents, employees, directors, and anyone acting on its behalf. Further, should it be necessary for the participant to return home due to medical reasons, disciplinary action or otherwise, we (I) hereby assume all transportation costs. Further authorization and permission is hereby given to said church to furnish any necessary transportation, food and lodging for this participant. The undersigned further hereby agree to hold harmless and indemnify said church, its directors, employees and agents, for any liability sustained by said church as the result of the negligent, willful or intentional acts of said participant, including expenses incurred attendant thereto.

MEDICAL AUTHORIZATION
